# North Carolina Office of Indigent Defense Services FY04 Public Defender & Private Assigned Counsel Services Cost-Effectiveness Analysis

## Key Findings

1. In FY04, PD offices saved IDS an estimated \$2.66 million from what it would have cost if PACs had handled their cases. This is an increase in savings of \$756,000 (40%) from FY03. The major reasons for the increase are: 1) a full-year of operation in the Forsyth office without first-year startup costs and 2) improved cost savings from the Cumberland office.
2. PD offices handled 31.6% of all PAC and PD cases combined, but accounted for 22.3% of total PAC and PD expenditures<sup>1</sup>. In FY03, PDs handled 27.5% of all cases and were 19.1% of the total cost.

3. Nine of the twelve PD offices were found to be cost-effective: Buncombe, Cumberland, Durham, Gaston, Guilford, Hoke/Scotland, Forsyth, Mecklenburg, and Robeson.
4. Some notable PD office improvements in FY04 include:

- The Carteret PD office, although still marginally not cost-effective, has steadily become more cost-effective over the last two years. In FY03, Carteret cost \$70,682 more than it would have cost PACs to handle their cases. In FY04, they narrowed that gap to \$47,404. Their productivity also increased for the second year in a row—from 488 misdemeanor units per attorney in FY03 to 573 units in FY04—a 19% improvement.

Carteret’s difficulties are due to their small size; the PD office has 2 attorneys and 1 support staff. The Carteret office is also investigating the feasibility of adding child abuse/neglect/dependency, special proceedings, and child support cases to their caseload. The Carteret office is also a key participant in Carteret’s drug court. This work does not result in traditional dispositions.

- The Chatham/Orange PD Office significantly improved their productivity in FY04, averaging 620 misdemeanor units per attorney last year, up from 521 units in FY03—a 17.3% improvement.
- The Cumberland PD office improved their cost-effectiveness significantly in FY04. Last year, the office saved \$264,114, up from \$60,744 in FY03. Their average number of misdemeanor units per attorney rose from 447 units in FY03 to 507 units in FY04—a 16.6% increase.

- The Forsyth PD Office completed their first full year of operations without any startup costs. The office saved \$252,004 in FY04. During their startup year, the office lost \$228,167, largely due to high startup costs and the fact that they were in operation for only 6 months of the year. The office was established January 1, 2003 and began closing cases around April 2003. IDS projected the Forsyth Office would save about \$446,000 per year.

In addition, Forsyth’s recoupment rate has rebounded to 8.84% after an initial sharp drop to just over 4%. The FY04 recoupment rate remains lower than the pre-PD office FY02 recoupment rate of 11.09%. This is a 2.25% difference in recoupment. The drop in recoupment, however, could have no connection with establishment of a PD office in Forsyth. There are 86 counties without a PD office. Of these counties, 48 experienced a drop in recoupment levels in FY04 from FY02 levels, with 38 counties experiencing a greater than 2% drop in recoupment levels. The impact of having a PD Office in Forsyth could range from no impact to as much as a 20% reduction (or \$43,506 negative impact) on recoupment. IDS will have more information about the impact on recoupment from establishing PD offices from monitoring the new District 1 PD office.

5. PD Offices that are not cost-effective tend to be smaller offices.

- The Pitt office, which generated \$12,944 in savings in FY02 and \$144,711 in losses in FY03, generated \$174,061 in losses last year. The office continued to improve their average number of misdemeanor units per attorney again last year—from 364 in FY02 to 373 in FY03 to 409 in FY04. Their average, however, remains significantly below other PD offices.

The almost \$30,000 increase in losses appears to be due to a combination of: 1) an almost \$25,000 increase in office costs and 2) disposing of fewer capital cases (from 7 in FY03 to 5 in FY04). Capital cases generate the greatest amount of savings for a PD office. Pitt’s Superior Court savings were about \$10,000 fewer last year than in FY03.

- The Chatham/Orange PD office’s cost-effectiveness remained relatively unchanged—just short of breaking even. The office improved their productivity significantly in FY04, averaging 620 misdemeanor units per attorney per year last year, up from 521 units in FY03—a 17% improvement. The lack of change in cost savings was due to a decline in capital cases. They handled 6 capital cases in FY03 and 2 cases in FY04. The office’s significant improvements in productivity offset most of this difference. Chatham/Orange appears to remain on the cusp of cost-effectiveness because of their small size; they have seven attorneys.

6. Disposition data shows that PD office withdrawals have significantly increased for a number of offices. The data indicates either a change in office appointing practice or a change regarding how the office is counting withdrawal dispositions. The wide variability in the number of withdrawals for each office also needs to be understood. The current definition for a withdrawal disposition is any case where the attorney puts in hours on a case beyond administrative functions like opening a file, etc. IDS intends to investigate this issue in the future, although it may be resolved when the new disposition rules go into effect, which are scheduled to take effect on July 1, 2005. Below is a list of the number of withdrawals per office, as well as withdraws as a percent of all non-withdrawal dispositions.

## Study Limitations

**Please note this study does not include any assessment about the quality of representation being provided.**

This is a cost analysis study only. Currently, IDS is unable to conduct a cost-benefit study.

A cost-benefit analysis on Public Defenders and Private Assigned Counsel would compare the cost, efficiency, and quality of their services.

- Cost—PD vs. PAC cost per case by case type
- Efficiency—the average hours it takes a PD vs. a PAC to dispose of similar cases
- Quality—the quality of the representation being received by clients of PDs vs. PACs

Data limitations, however, do not allow such a comprehensive analysis at this time. IDS does not have data on the quality of representation being provided or the average hours it takes a PD to dispose of a case by type of case. PD offices do not currently collect any data on hours per case.

The data available does allow IDS to compare the relative costs of PACs vs. PD offices and broadly assess their relative rates of efficiency by converting office caseloads into misdemeanor units.

Not all costs associated with PACs could be quantified at this time. Research confirms that there are additional costs to the State, although not directly to IDS, associated with private assigned counsel that have not yet been quantified. These include, for example, court administrative costs to maintain PAC rosters, notify attorneys of cases, notify clients of attorneys, process fee applications to the AOC, review PAC fee applications, etc. IDS hopes to identify these State costs in the future.

Not all costs associated with PD offices could be quantified at this time. Research also confirms that there are additional PD costs to the State, although not directly to IDS, that have not yet been quantified. These include, for example, what it costs counties to provide office space to Public Defender offices as they are required to do by statute. These costs may be negligible if a county houses the PD office in existing office space, as is true for the Durham PD office. IDS hopes to quantify these State costs in the future.

Moreover, IDS is aware that PD offices provide value-added activities, such as appointing PACs to cases or assisting clients after a case has been disposed, that are not reflected in the cost-effectiveness analysis. PACs may provide value-added activities as well. IDS intends to incorporate these value-added activities into our cost-effectiveness studies in the near future.
