## If you have a questions or concerns about a Civil Case or a Minor Traffic Violation:

IDS can only assist with inquiries in which clients are:

- (1) charged with a crime for which they may face jail/prison time, and
- (2) charged with a crime and are entitled to court-appointed legal counsel.

Some examples of civil cases include:

- Family Issues
- Contract Disputes
- Negligence
- Defamation
- Medical Malpractice
- Fraud
- Personal Injury Claims, etc.

If you do not have a court-appointed attorney, and if you are NOT facing charges that could potentially cause you to serve time, you are encouraged to reach out to the following:
