[] demonstrate that he or she has the required legal knowledge and skill necessary to represent clients in misdemeanor cases and that he or she will apply that knowledge and skill with appropriate thoroughness and preparation.

In exchange, the Contractor agrees to the following additional obligations:

- Meet with the Regional Defender in your district every other week to review and preview the MAC cases, in a format, time and manner to be determined by the Regional Defender, for the first 6 months of the contract. At the discretion of the Regional Defender, this time may be shortened. The attorney may bill for this to the specific cases discussed.
- 2. The contracting attorney shall review and/or view the following free resources in the next 90 days, understanding that the contracting attorney continues to have an ethical duty to know the current law and these resources are no substitute for that:
